Many of these dead panels are dumped in landfills, even though they contain valuable elements such as silicon, silver, and copper. The vast majority of a panel consists of glass, aluminum, and silicon.

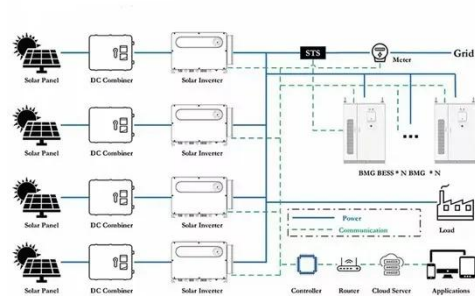
