Since January 1, Lithuania has banned the use of software or cloud services from Chinese manufacturers in solar and wind power plants, as well as electricity storage devices and inverters with a capacity of more than 100 kilowatts. “Article 733: Security Requirements for the Control Systems of Electricity Devices” aims to strengthen security measures for electricity. Lithuanian lawmakers on Tuesday adopted legislation intended to block Chinese companies from getting remote access to the control systems of solar and wind farms and batteries larger than 100 kW.
