Overview

Solar projects that begin construction after J, now need to meet 45% domestic content instead of 40% to obtain the domestic content bonus adder of 10%. And here's the kicker: that requirement increases annually by 5%. At its simplest, the domestic content bonus boosts the value of federal clean energy tax credits when projects can prove enough of their equipment is manufactured in the United States. For projects using the Investment Tax Credit (ITC), the bonus can raise the credit rate by 10 percentage points. A. WASHINGTON - Today, the U. 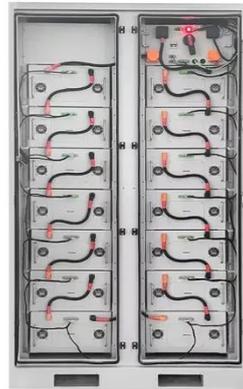


